- 1. By-law No. 211, the Town of Sackville Municipal Plan, is amended by changing the designation as shown on the Future Land Use Map Figure "2" of the Town of Sackville Municipal Plan for the lands known as PID#'s 00891069 and 70300850 and shown on Schedule "A" attached hereto and forming part hereof, from Urban Residential to Highway Commercial.

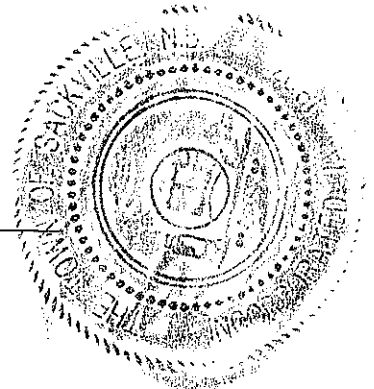

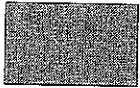
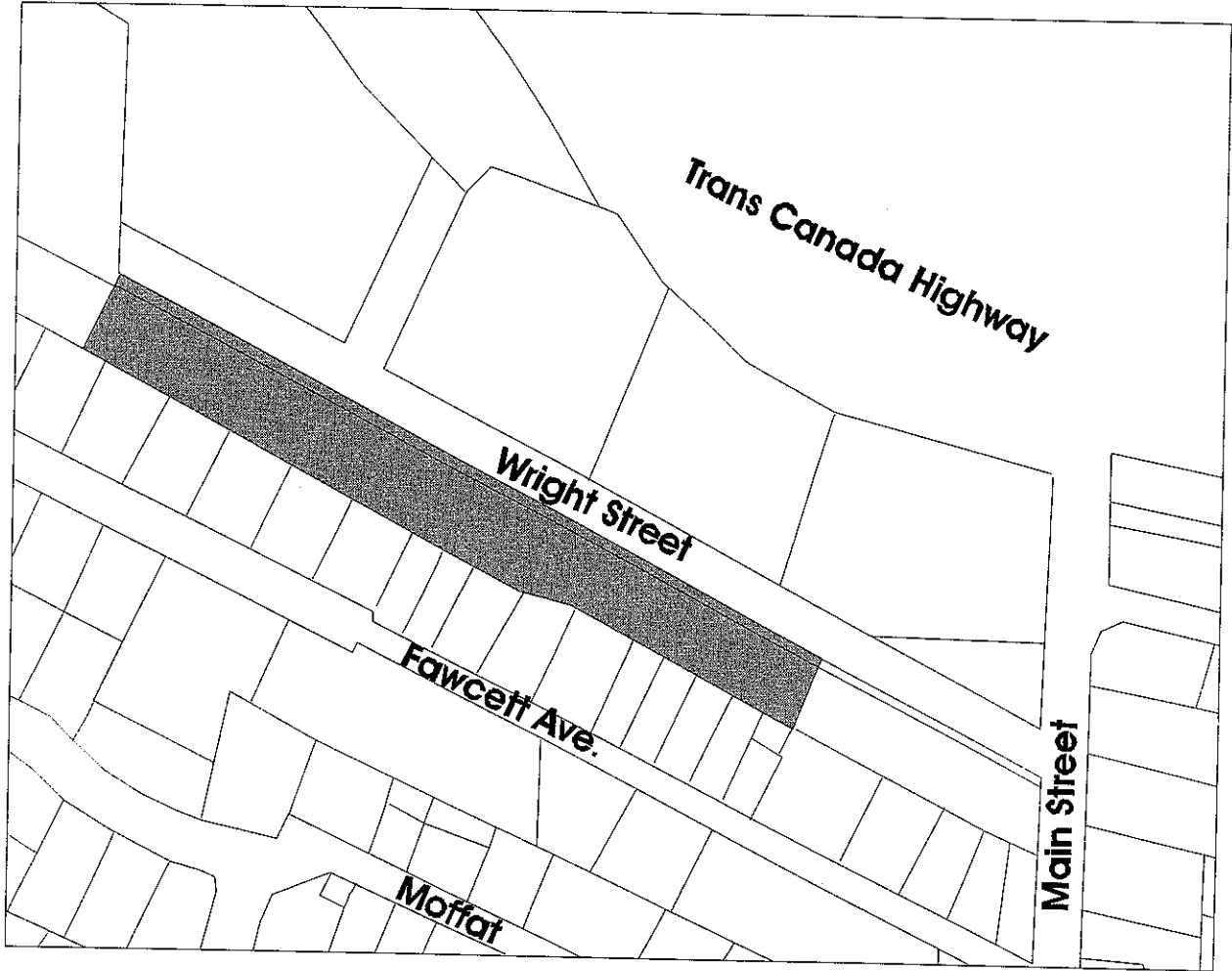

SOLEMN DECLARATION

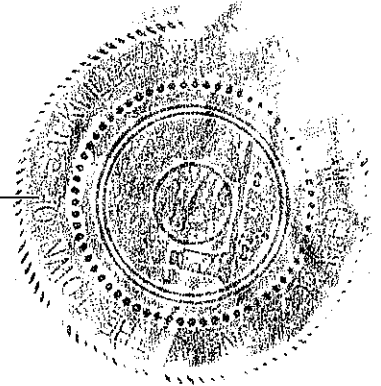
