Read a second time this 8th day of November, 2010.

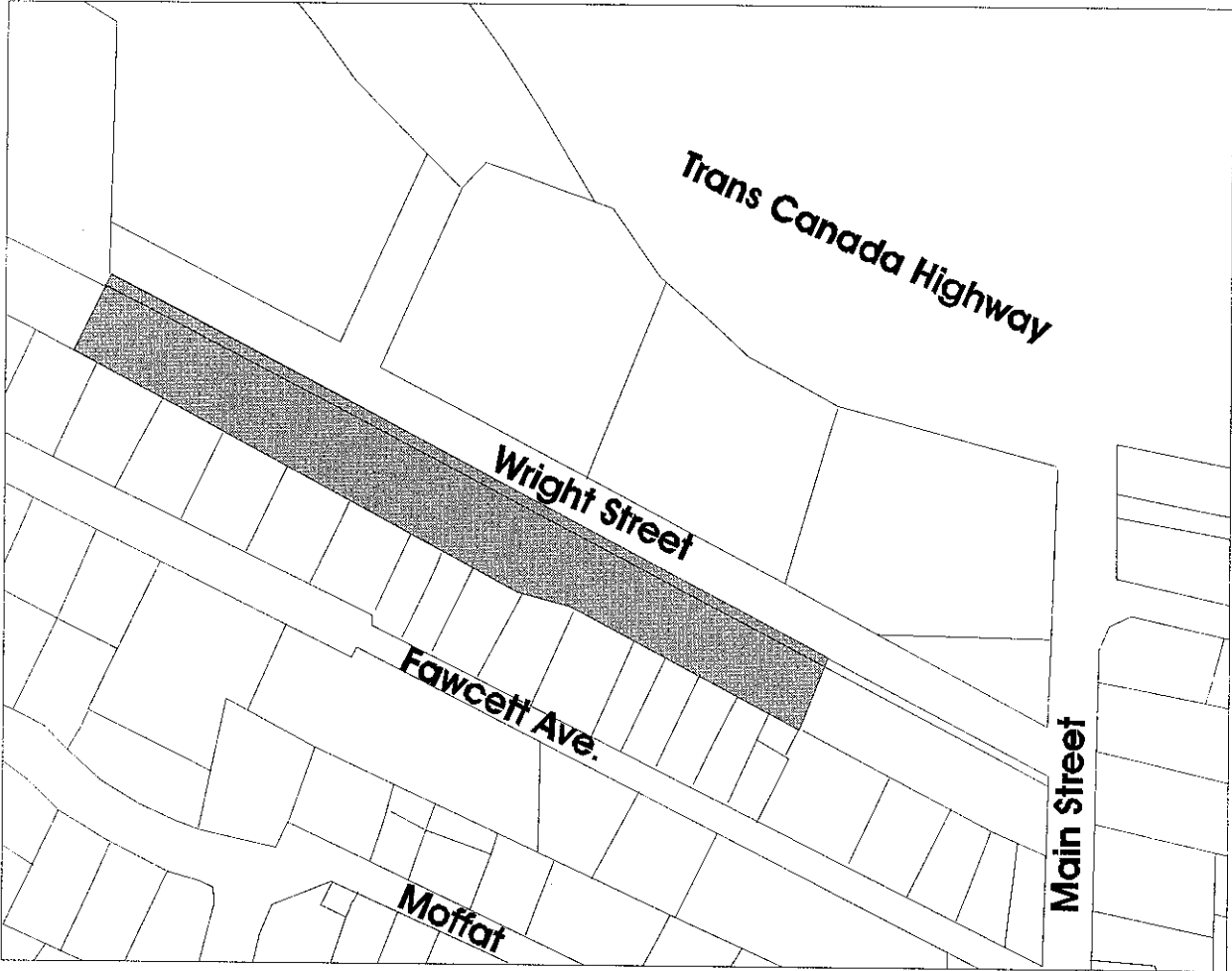
